

PERMISSION TO PARTICIPATE FOR MINORS (17 AND UNDER)

WARNING: There is an inherent risk in the participation of activities involving skateboarding, inline skating, paintball, and freestyle or mountain and off-road bicycling. Users of the Park, by participation, accept the risks inherent in such participation of which the ordinary, prudent person is, or should, be aware. Users have a duty to exercise good judgment and act in a responsible manner while using the Park and obey all oral and written warning prior to or during participation. Activities involving skateboarding, inline skating, paintball, and freestyle or mountain and off-road bicycling are hazardous, recreational activities and may result in serious injury including, but not limited to, paralysis, brain damage, concussion, broken bones or death. **The City of Palm Bay does not assume any responsibility for any injury or death. Each participant at the Park does so at his or her own risk.**

Read this form completely and carefully. You are agreeing to let your minor child engage in a potentially dangerous activity. You are agreeing that, even if the City of Palm Bay, its departments, employees, contractors, volunteers, specialists and agents (hereinafter “Released Parties”) use reasonable care in providing this activity, there is a chance your child may be seriously injured or killed by participating in this activity because there are certain dangers inherent in the activity which cannot be avoided or eliminated.

By signing this form, you are giving or forever releasing your child’s right and your right as the child’s parent or guardian to recover from any or all of the Released Parties in a lawsuit for any personal injury, including death, to your child or any property damage that results from the risks that are a natural part of the activity. You have the absolute right to refuse to sign this form with the understanding that your minor child shall not be permitted to participate in these activities at any City of Palm Bay Park.

WAIVER OF LIABILITY

I agree that, in consideration for my child’s in any activity involving skateboarding, inline skating, paintball, and freestyle or mountain and off-road bicycling at any City of Palm Bay Park, I shall hold harmless and fully indemnify and defend the City of Palm Bay, its departments, employees, officials, coaches, volunteers, contractors, specialists, and agents (hereinafter “Released Parties”) from any and all causes of action, claims, damages, costs including but not limited to attorney’s fees and costs, which may arise from any cause of action made by me or by, through or on behalf of my child, even if the damages, injuries or death are caused in whole or in part by the negligence of the Released Parties.

I hereby waive, release, discharge and agree not to sue the Released Parties for any and all causes of actions, claims or damages arising out of or resulting from my child’s participation in any activity involving skateboarding, inline skating, paintball, and freestyle or mountain and off-

road bicycling, including but not limited to damages, injuries, or death arising out of risks that are a natural part of these activities.

I agree that in consideration for my child being permitted to participate in the activity, I assume full responsibility for any loss of property, accident, bodily injury, or death as a result of my child's participation in this activity.

I expressly agree the Release and Waiver of Liability Agreement is intended to be as broad and inclusive as is permitted by the laws of the State of Florida and that if any portion thereof is held invalid, I agree that the balance shall, notwithstanding, continue in full legal force and effect.

I acknowledge that I have read (or have had read to me) each and every one of the provisions in this waiver, release of liability and indemnification agreement, and that I understand each of the provisions in this agreement and that I agree to abide by them
